

# Petition for Ohio Residency Categories and Guidelines

Select the category that best applies to you (*choose only one*). Indicate on the residency petition which provision you are applying under, and submit **all** required documentation for that category.

**Documentation Notes:** Applications with incomplete or missing documentation will not be considered. Only submit the requested documentation for the provision you are applying for. Any documentation submitted that is not required for this application will be destroyed. No retroactive residency petitions will be accepted.

**For Dependents:** Please submit a copy of your spouse or parent's previous year's state and federal tax returns (**only the first page**, **which shows you listed as a dependent**). Also, please submit a copy of your marriage certificate if you did not file taxes jointly.\*

\*Additional documentation may be required.

#### CATEGORIES AND EXCEPTIONS FOR RESIDENCY

#### Category C1: Dependent, 12 Months

I am a financial dependent of a legal resident of Ohio who has lived in the state for 12 consecutive months prior to the start of the semester I am applying for.

**Required Documentation:** If you are a **dependent**, only submit the tax forms of the individual claiming you.

Parent, guardian or spouse Ohio-issued ID Most recent Ohio tax return

Most recent federal tax return (showing you as a dependent or spouse)

Current lease, mortgage statement or notarized domicile form

#### Category C2: Independent, 12 Months

I am a financially independent student who has lived in Ohio for 12 consecutive months prior to the start of the semester I am applying for.

#### **Required Documentation:**

Student Ohio-issued ID

Most recent Ohio tax return

Most recent federal tax return

Current lease, mortgage statement or

notarized domicile form

#### Category C3\*: Dependent, Relocation

I am a dependent student following a relocated parent, guardian or spouse who has lived in Ohio for less than 12 consecutive months. They obtained full-time employment in Ohio prior to the start of the semester I am applying for.

\*This category must be renewed every semester.

**Required Documentation:** If you are a **dependent**, only submit the tax forms of the individual claiming you.

Parent, guardian or spouse Ohio-issued ID Most recent federal tax return (showing you as a dependent or spouse)

Current lease, mortgage statement or notarized domicile form

Proof of Employment: A letter from the employer on company letterhead stating:

Name of the employed person

Date the employment began

Statement that the employee works full time

Employee's annual salary

#### Category C4: U.S. Military Veteran

I am a U.S. military veteran, the spouse of a veteran, or the dependent of a veteran who has been honorably or medically discharged with at least one year of service. (This includes the spouse or dependent of service personnel categorized as KIA, MIA or POW.) I have lived in Ohio prior to the start of the semester I am applying for.

**Required Documentation**: If you are a **dependent**, only submit the tax forms of the individual claiming you.

# **Category C5: Forever Buckeye**

I am currently living in Ohio and graduated from an Ohio high school as an Ohio resident.\*

# **Required Documentation:**

Student Ohio-issued ID

Official Ohio high school transcript with graduation date

Current lease, mortgage statement or notarized domicile form

\*Students who received a GED diploma will not qualify under this provision.

#### **Exception E1: Independent, Part-Time**

I am an independent student and have resided in Ohio for less than 12 consecutive months. I am employed in Ohio and am attending as a part-time student.\*

\*This exception must be renewed every semester.

#### **Required Documentation:**

Student Ohio-issued ID

Most recent federal tax return

Current lease, mortgage statement or notarized domicile form

Proof of Employment: A letter from the employer on company letterhead stating:

Name of the employed person

Date the employment began

Statement that the employee works full time

Employee's annual salary

#### **Exception E2: U.S. Military**

I am military personnel or the spouse or dependent of a person on active military duty who is stationed outside of Ohio and has maintained Ohio as their home of record.

**Required Documentation**: If you are a **dependent**, only submit the tax forms of the individual claiming you.

Student Ohio-issued ID

If a dependent, parent, guardian or spouse Ohio-issued ID

Most recent Ohio tax return

Most recent federal tax return

Copy of military orders showing Ohio as their home state of record

Current lease, mortgage statement or notarized domicile form

## **Exception E3: U.S. Military**

I am military personnel or the spouse or dependent of a person on active military duty who is currently stationed in Ohio.

**Required Documentation**: If you are a **dependent**, only submit the tax forms of the individual claiming you.

Student Ohio-issued ID

Parent, guardian or spouse Ohio-issued ID

Most recent federal tax return

Copy of military orders showing stationing in Ohio

Current lease, mortgage statement or notarized domicile form

#### **Exception E4: Employer Transfer**

An employer has transferred me, my parent or my legal guardian beyond the territorial limits of the United States while maintaining Ohio residency.

**Required Documentation:** If you are a **dependent**, only submit the tax forms of the individual claiming you.

Student Ohio-issued ID

Parent, guardian or spouse Ohio-issued ID

Most recent Ohio tax return

Most recent federal tax return

Letter from the employer verifying the transfer

Current lease, mortgage statement or

notarized domicile form

#### **Exception E5: Migrant Worker**

My parent, legal guardian or I am employed as a migrant worker in Ohio and have worked in Ohio for at least four months for each of the past three years.

# **Required Documentation:**

Student Ohio-issued ID

If a dependent, parent, guardian or spouse Ohio-issued ID

Proof of Ohio work for at least four months each of the past three years\*

Certificate from the Ohio Migrant

**Education Center** 

Letter from the employer

Letter from the Ohio Department of Job and Family Services

\*All of these documents must certify the date of employment or dependency.

# **Exception E6: Community Service**

My parent, legal guardian, spouse or I were a resident of Ohio prior to a community service position, such as VISTA, AmeriCorps, Peace Corps or an elected or appointed public office for up to 24 consecutive months.

**Required Documentation:** If you are a **dependent**, only submit the tax forms of the individual claiming you.

Student Ohio-issued ID

If a dependent, parent, guardian or spouse Ohio-issued ID

Most recent federal tax return

Sworn statement from the community service group verifying Ohio as the home of record Current lease, mortgage statement or notarized domicile form

#### **Exception E7: Marital Hardship**

I returned to Cuyahoga County or another Ohio county due to marital hardship, which includes taking legal steps to end my marriage and re-establishing financial dependence upon a parent or legal guardian (receiving greater than 50% of their support). My dependents will be considered residents of Cuyahoga County or another Ohio county.

# Required Documentation:

Student Ohio-issued ID

Document verifying impending marital status Notarized statement of financial dependency Current lease, mortgage statement or notarized domicile form

#### **Exception E8: Ohio National Guard**

I am a member of the Ohio National Guard who is domiciled in Cuyahoga County or another Ohio county. My spouse and dependents shall be considered residents of Cuyahoga County or another Ohio county while I serve in the Ohio National Guard.

#### **Required Documentation:**

Student Ohio-issued ID
Ohio National Guard ID
Most recent federal tax return
Current lease, mortgage statement or
notarized domicile form

#### **Exception E9: DACA**

I am a student granted Deferred Action for Childhood Arrivals (DACA) under the U.S. Citizenship and Immigration Services.

#### **Required Documentation:**

Student Ohio-issued ID

Completed DACA form

Employment authorization card with Category 33 listed

Copy of an unexpired USCIS I-797 receipt showing approval has been granted and indicating Category 33

## **Exception E10: Relocation, Full-Time**

I am a student, and my parents moved out of the state.

The state residency guidelines have "grandfather clauses" to address this. Tri-C will still classify you as an Ohio resident through the completion of one degree program if your parent(s) were Ohio residents and moved out of the state. However, you must maintain continuous full-time enrollment.

# Required Documentation:

Letter from the employer stating that the parent has moved to a new position

Lease agreement or mortgage statement showing they lived in Ohio

Previous year's federal or state tax returns
