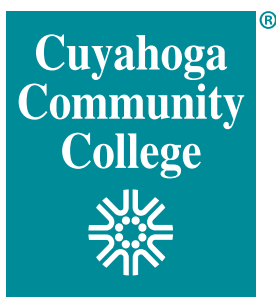

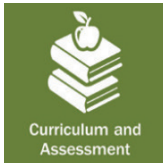

Engage and explore effective practices such as active learning, innovative teaching techniques and student engagement.



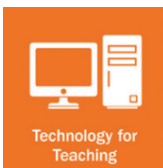

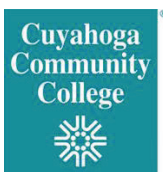

Disrupt, Engage, Empower: Rethinking Education for Deeper Learning

Dr. Candy Van Buskirk, *Assistant Superintendent, Career Academy Network of Public Schools, South Bend, Indiana*

This presentation explores why and how we must adapt and inspire our educational practices to disrupt the status quo, increase student agency, and enhance student engagement — ensuring that deeper learning takes place for all students.

With two decades of experience spanning K-12 and higher education, Dr. Candy Van Buskirk is dedicated to transforming education through innovation, equity and student-centered learning. As the founder of Lead E2 LLC, an educational leadership consultancy, she focuses on advancing leadership practices that drive excellence and equity. She has been recognized as a women's basketball coach of the year at both the college and high school levels and founded Coach Camp Candy, a K-12 basketball camp. She helped collaborate and lead a grant-funded partnership between the Career Academy Network of Public Schools and the Boys & Girls Club of St. Joseph County, Indiana. Dr. Van Buskirk recently published her first book, *Learn Outside: Rising Together To Disrupt the Status Quo in Education*, which challenges and inspires educators to create more equitable and engaging learning environments.

A1 | A Trauma-Informed Campus for All: Adjunct Faculty Edition

Learn about the impact of childhood trauma on the lives of adults by exploring how adverse childhood experiences (ACEs) may manifest in our students and negatively impact their academic performance, attendance and overall success. We will shift from asking, “What’s wrong with you?” or “Why are you behaving that way?” to asking, “What happened to you?” We will discuss how our curiosity and empathy, inside and outside the classroom, may foster resilience and perseverance in our students, resulting in a greater probability of retention and graduation.

A2 | AI-Powered Creativity: Igniting Innovation in the Classroom

Explore how artificial intelligence can be leveraged to spark creativity, enhance critical thinking, and engage students in innovative learning experiences. Participants will discover practical AI tools that foster interactive discussions, problem-solving and project-based learning. The session includes hands-on activities demonstrating AI-powered brainstorming, content generation, and adaptive learning techniques that help students develop resilience and adaptability. Attendees will leave with actionable strategies to integrate AI into their teaching, transforming traditional learning into an immersive and dynamic experience.

A3 | College Credit Plus Faculty Orientation

Adapting college teaching practices and faculty expectations is critical for a strong start to an academic year. The College Credit Plus (CCP) New Faculty Orientation provides CCP adjunct faculty with information and strategies needed for success in their new role as members of the College's faculty. This session includes learning Tri-C's policies and navigating its systems, accessing classroom resources, promoting academic integrity, developing content and assignments that meet the rigor and pace of college classes, and fostering student engagement and success in college.

A4 | Enhancing Reading Comprehension: Applying Cognitive Load Theory in Content Instruction

Understanding and managing cognitive load is essential for helping students navigate complex texts across disciplines. This session explores how cognitive load theory and the science of reading can enhance content instruction, particularly in reading-intensive courses. Participants will gain practical strategies to reduce cognitive overload, support student engagement with challenging material, and improve retention and comprehension. By applying evidence-based approaches, faculty can create more accessible, effective learning experiences that promote academic resilience and deeper understanding.

1. Identify cognitive load factors that impact students' ability to process and retain complex written material
2. Apply strategies to reduce cognitive overload in reading-heavy assignments across disciplines
3. Design course materials and activities that promote better engagement, comprehension and retention of text-heavy content



A5 | Raising the Bar: Inspiring Academic Excellence Without Compromise

Instructors strive to help their students achieve peak performance, yet well-meaning compromises can sometimes hinder this goal. These compromises may even lead to a decline in academic standards. This session will explore the reasons behind this issue and provide strategies to help students reach their highest potential.

B1 | Contemplative Pedagogy: Connecting With the Practice of Teaching



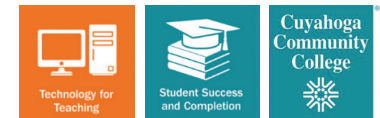
Faculty nationwide are experiencing high levels of burnout in both K-12 and postsecondary education. Despite significant changes in educational institutions, little focus has been placed on teaching as a reflective practice. This presentation explores the psychological foundations of contemplative practices, including mindfulness and meditation, and their benefits for educators. Participants will learn practical strategies to reduce stress, enhance their teaching experience, and foster healthier learning environments for students.

This presentation introduces Brightspace, the new learning management system (LMS), to faculty and staff. It covers key features such as course creation, content organization and student progress tracking. Attendees will explore interactive tools that enhance engagement and discover the benefits of streamlined course management. By the end, participants will feel confident using Brightspace and inspired to maximize its capabilities, driving adoption across the institution.

This session will examine the current landscape of accessibility expectations, highlighting key challenges and opportunities. Learn how to align metrics with goals, implement corrective actions, and foster a culture of continuous improvement that drives measurable student success.

C1 | Amplifying Student Voices by Fostering Genuine Connections



When students connect on a more human level, they begin to realize that other people have lives just as imperfect as their own. As students connect, they feel safer, leading to a greater sense of connection, empathy and camaraderie. Learn and experience some strategies beyond icebreakers to help students feel more comfortable speaking up in class and connecting. These strategies lead to powerful gains in later classroom interaction and fellowship.

C2 | Help Is Here: Mental Wellness and Suicide Prevention Resources



There have likely been many times you wished you had mental wellness and suicide prevention resources for you and your students. Good news: Help Is Here! Join us for a discussion on destigmatizing mental health disorders and take a tour of what you can share with your students: online resources, a mobile app and helpful handouts. There are even premade Help Is Here activities you can use in class to ensure students become more familiar with the resources. Learn how you can inform students about our publicly accessible information and create a positive ripple effect on mental wellness.

 3. Approach students more confidently who are suspected of, or who share they are, struggling with mental health by learning what to say or not say

C3 | Refresh and Renew: College Credit Plus Faculty Update and Development



This session focuses on strengthening College Credit Plus (CCP) adjunct faculty teaching practices and will provide a refresher and update on instructional policies and practices. In addition to gaining access to instructional resources, a panel of veteran CCP faculty and members of the CCP Faculty Advisory Committee will share strategies for designing course experiences and promoting student success at their off-site or campus location. Associate deans will also provide tips on getting the most out of their relationships with deans, faculty coordinators and faculty mentors.

Adding a simple sorting activity to a lesson creates an easy introduction, practice routine, or formative assessment while allowing students to work collaboratively and build resilience. In this session, we'll look at how to use sorts in lessons and what students say about them, discuss tech tools that can be used for sorts, and brainstorm ideas for sorts in your disciplines.
